	competitions, LPF rules and championship regulations.		
Participants	Swimming Masters from the age of 25 years, as well as any swimming enthusiast starting from the age of 18 years in the age group "0". All participants must be registered members of World Aquatics approved national federation		
	member teams, clubs or region (with a valid Masters license).		
	A team is to be represented by not more than 10 swimmers.		
	Two individual event points (the highest scores), obtained applying the newest DSV Master		
	Performance Table, will be summed up for the best swimmers scoring. The following calculation approach is applied for team scoring:		
	<ul> <li>Individual event participant gains 10 points for the 1st place (in accordance with DSV)</li> </ul>		
	Master Performance Table 2016); 9 points for the 2nd place; 8 points for the 3rd		
	place; 7 points for the 4th place; 6 points for the 5th; 5 points - for the 6th; 4 points -		
	for the 7th; 3 points - for the 8th; 2 points - for the 9th; 1 point – for the 10th.

Personal data	The controller of personal data, including accreditation data, is PK "KOBRAS";
	Legal basis for the processing of personal data - data processing is necessary for the controller to perform the duties specified in regulatory enactments, especially the Sports Law, and in these Regulations.
	The purpose of personal data processing is the registration of persons involved in the championship, accreditation, registration and analysis of the performed activities and achieved results, registration of the use of material values, as well as popularization and media coverage of the championship.
	During the "AMBER CUP" Championship, a photo and video recording of the event and its participants will be made and published (including, but not limited to, live broadcast, storage of photo and video materials in the public access archive and re-use of these materials), transferring such rights to LPF selected partners.
	Data on the number of participants in "AMBER CUP" Championship, regional and educational affiliation, as well as sports achievements will be published in both aggregated and detailed form.
	Personal data will be received by PK "KOBRAS" employees and its partners - to the extent necessary for the performance of the duties assigned to them.
	Personal data will be stored in accordance with the procedures specified in regulatory enactments until the expiry of the term specified therein.
	Participants have the right to request access to their personal data from the controller, to correct or delete incorrect or outdated data, object to the processing of their personal data (personal data processing is necessary to ensure participation in the "The RIGAS AMBER CUP" Championship, therefore termination of personal data processing will also terminate such participation), to transfer their personal data, as well as, in case they consider that their personal data is being processed illegally, to file a complaint with the State Data Inspectorate.
Actual	Photographers may be present during the competition to capture participants throughout the event. The organizers have the right to use the photographs and video materials taken during the competition for marketing and promotional purposes without the need for approval from the individuals featured in them.
